YEAR IN RETROSPECT & STATE OF AFFAIRS:

The gross sales and other income for the financial year under review were Rs. 5844.63 Lakhs as against Rs. 94.63 Lakhs for the previous financial year registering an increase of 8277 %. The loss after tax from continuing operations including extraordinary and exceptional items was Rs. 13,395.39 lakhs for the financial year under review as against a loss of Rs. 10,769.37 lakhs for the previous financial year. The increase in loss is on account of not availability of vessel for operation due to ongoing repair work post an accident on 8th March, 2020 and increased insurance and interest cost. The vessel became operational from 10th October 2022.

Opinion

We are independent of the Company in accordance with the Code of Ethics issued by the Institute of Chartered Accountants of India together with the ethical requirements that are relevant to our audit of the financial statements under the provisions of the Companies Act, 2013 and the Rules thereunder, and we have fulfilled our other ethical responsibilities in accordance with these requirements and the Code of Ethics.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Key Audit Matters

Key audit matters are those matters that, in our professional judgment, were of most significance in the audit of the Ind AS Financial Statements of the current period. These matters were addressed in the context of our audit of the Ind AS Financial Statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters.

We have determined the matters described below to be the key audit matters to be communicated in our report:

1. <u>Revenue stream of the company impacted due to an accident and subsequent repairs (Refer</u> Note 21.15)

On March 08, 2020 there was an accident on board the Company's Vessel, involving an uncontrolled boom movement of the main crane causing the boom to collapse into the sea along with the jacket. Subsequently, the Vessel returned to port and sailed to ASL Shipyard Batam where the repair activities was carried out. During the year, the repair work has been completed and the vessel became operational on October 12, 2022. Vessel has been utilized only for part of the year which had a significant impact of the revenue stream of the Company. This event does not have any impact on the "Going Concern" accounting assumption followed by the Company.

Our Response

- We have been informed that the management of the company has estimated the cost of repairs and also lodged a claim with insurance companies. During the year, second tranche of claim has been received from insurance company amounting to Rs. 9,947 Lakhs. During the year, the crane repairs as well as overall repairs activity completed and the vessel became operational on October 12, 2022
- Basis the perusal of the minutes of the Board Meeting, regular updates of the repairs work and the insurance claim has been reported to JV partners from time to time.
- The consistency and appropriateness of the management estimates and assumptions used for arriving at the recoverable amount of insurance claim was discussed with the management.
- Considered the appropriateness of the suitable disclosures in the Financial Statements for the year ended March 31, 2023.

Information Other than the Ind AS Financial Statements and Auditor's Report Thereon

The Company's Board of Directors is responsible for preparation of other information. The other information comprises information included in the Management discussion and analysis, the Directors' Report including Annexures to Directors' Report (collectively called as "Other information") but does not include the Ind AS Financial Statements and our auditor's report

thereon. The Other information is expected to be made available to us after the date of this auditor's report.

Our opinion on the financial statements does not cover the other information and we do not express any form of assurance conclusion thereon.

In connection with our audit of the financial statements, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the Ind AS Financial Statements or our knowledge obtained in the audit or otherwise appears to be materially misstated.

When we read the Other information, if, we conclude that there is a material misstatement therein, we are required to communicate the matters to those charged with governance.

Responsibility of Management for the Financial Statements

The Company's Board of Directors is responsible for the matters stated in Section 134(5) of the Companies Act,2013 ("the Act") with respect to the preparation of these Ind AS Financial Statements that give a true and fair view of state of affairs (financial position),changes in equity, loss (financial performance including other comprehensive income) and cash flows and of the company of in accordance with the accounting principles generally accepted in India, including the Accounting Standards ("Ind AS") prescribed under Section 133 of the Act, read with Rules 4 of the Companies (Indian Accounting Standards) Rules, 2015, as amended.

This responsibility also includes maintenance of adequate accounting records in accordance with the provision of the Act for safeguarding of the assets of the Company and for preventing and detecting frauds and other irregularities; selection and application of appropriate accounting policies; making judgments and estimates that are reasonable and prudent; and design, implementation and maintenance of adequate internal financial controls, that were operating effectively for ensuring the accuracy and completeness of the accounting records, relevant to the preparation and presentation of the Ind AS Financial Statements that give a true and fair view and are free from material misstatement, whether due to fraud or error.

If we conclude that a material uncertainty exists, we are required to draw attention in our auditor's report to the related disclosures in the Ind AS Financial Statements or, if such disclosures are inadequate, to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the Company to cease to continue as a going concern.

• Evaluate the overall presentation, structure and content of the Ind AS Financial Statements, including the disclosures, and whether the Ind AS Financial Statements represent the underlying transactions and events in a manner that achieves fair presentation.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

We also provide those charged with governance with a statement that we have complied with relevant ethical requirements regarding independence, and to communicate with them all relationships and other matters that may reasonably be thought to bear on our independence, and where applicable, related safeguards.

L&T Sapura Shipping Private Limited

Significant accounting policies

20.1. General Information:

L&T Sapura Shipping Private Limited (LTSSPL) is a joint venture between Larsen Toubro Limited (L&T) and Sapura Energy Berhad, Malaysia (Sapura) which has invested through its wholly owned subsidiary Sapura Nautical Power Pte Limited, Singapore (Nautical) (Erstwhile - Nautical Power Pte Limited, Singapore). L&T holds 60% of the share capital and Nautical holds 40%. The registered office of the Company is at Mount Poonamallee Road, P.O. Box. No.979, Manapakkam, Chennai 600089.

The Company owns and operates a Heavy Lift cum Pipe Lay Vessel (HLPV) which is used for installation of offshore platforms and laying of pipes and cables under the sea for the Hydrocarbon Upstream Industry.

20.2. Statement of compliance

The Company's financial statements have been prepared in accordance with the provisions of the Companies Act, 2013 and the Indian Accounting Standards ("Ind AS") notified under the Companies (Indian Accounting Standards) Rules, 2015 issued by Ministry of Corporate Affairs in respect of sections 133 read with sub-section (1) of section 210A of the Companies Act, 1956 (1 of 1956). In addition, the guidance notes/announcements issued by the Institute of Chartered Accountants of India (ICAI) are also applied except where compliance with other statutory promulgations require a different treatment.

These financials statements have been approved for issue by the Board of Directors at their meeting held on 28th April, 2023.

20.3. Key sources of estimation:

The preparation of financial statements in conformity with Ind AS requires that management of the Company makes estimates and assumptions that affect the reported amounts of income and expenses of the period, the reported balances of assets and liabilities and the disclosures relating to contingent liabilities as on the date of the financial statements. Examples of such estimates include the useful lives of tangible and intangible fixed assets and allowance for doubtful debts/advances. Differences, if any, between the actual results and estimates are recognised in the period in which the results are known.

20.4. Presentation of financial statements

The balance sheet and the statement of profit and loss are prepared and presented in the format prescribed in the schedule III to the Companies Act, 2013 ("the Act"). The statement of cash flows has been prepared and presented as per the requirements of Ind AS 7 "Statement of Cash flows". The disclosure requirements with respect to items in the balance sheet and statement of profit and loss, as prescribed in the schedule III to the Act, are presented by way of notes forming part of the financial statements along with the other notes required to be disclosed under the notified Accounting Standards.

20.5. Operating cycle for current and non-current classification

Operating cycle for the business activities of the company covers the duration of the specific project/contract/product line/service including the defect liability period, wherever applicable and extends up to the realisation of receivables (including retention monies) within the agreed credit period normally applicable to the respective lines of business.

20.6. Revenue recognition

- **20.6.1.** The Company earns revenue by chartering out the vessel on time charter basis. The revenue under time charter is recognized based on the terms of the charter party agreement.
- **20.6.2.** Interest income is recognized at applicable rates on the fixed deposit with banks on accrual basis.
- **20.6.3.** Other items of income are accounted as and when the right to receive arises.

20.7 Foreign currencies

The functional currency of the Company is United States Dollar. The Company is in business of operating a specialised vessel. Its revenue and major items of costs are denominated in United States Dollars. Accordingly, the Company uses United States Dollar as its functional currency.

The presentation currency of the Company is Indian Rupee as the company is an Indian Company and has compliance requirements in India.

Company converts the balance sheet items from functional currency to presentation currency at the closing spot rate date except for share capital and statutory reserves. Items of profit and loss account are translated to presentation currency at the average rates. The resulting exchange differences are accounted in other comprehensive income and accumulated in equity as foreign currency translation reserve.

Accordingly, the disclosures given in the Notes are basis the above translated amounts and bears foreign currency rate adjustments.

Transactions and translations

The balances in foreign currencies are translated into the functional currency at the rate prevailing on the transaction date.

Transaction gains or losses realized upon settlement of foreign currency transactions are accounted in the statement of profit and loss.

20.8 Property, plant and equipment:

Property, plant and equipment are stated at cost, less accumulated depreciation and impairment, if any. Costs directly attributable to acquisition are capitalized until the property, plant and equipment are ready for use, as intended by management. The Company depreciates property, plant and equipment over their estimated useful lives using the straight-line method. The estimated useful lives of assets are as follows:

Depreciation is provided in the accounts based on useful life of assets as per schedule II of the Companies Act, 2013.

Depreciation for additions to / deductions is calculated pro rata from / to the month of additions / deductions. Depreciation method is reviewed at each financial year end to reflect the expected pattern of consumption of the future economic benefits embodied in the asset. The estimated useful life and residual values are also reviewed at each financial year end and the effect of any change in the estimates of useful life/residual value is accounted on prospective basis.

Company carries out dry dock of its vessel once in five years. All the expenses pertaining to the dry dock activities in dry docking period are capitalised and depreciated over a period of 5 years as per IND AS 16.

Capital spares are recognised as Property Plant and Equipment if the recognition criteria under Ind AS 16 is met and are depreciated when they are put into use.

All other fixed assets are stated at cost less accumulated depreciation and accumulated impairment losses.

20.9 Intangible assets and amortization

Intangible assets are recognised when it is probable that the future economic benefits that are attributable to the asset will flow to the enterprise and the cost of the asset can be measured reliably. Intangible assets are stated at original cost net of tax/duty credits availed, if any, less accumulated amortisation and cumulative impairment. Administrative and other general overhead expenses that are specifically attributable to acquisition of intangible assets are allocated and capitalised as a part of the cost of the intangible assets. The intangible asset owned by Company consists of an accounting software and the estimated useful life for the same is 6 years.

20.10 Impairment of assets

20.10.1 Impairment of financial assets:

The Company applies a separate model of the expected credit loss, which involves use of a provision matrix constructed on the basis of historical credit loss experience as permitted under Ind AS 109 for recognizing impairment loss on financial assets measured at amortised cost, trade receivables and other contractual rights to receive cash or other financial assets, as follows:

- **20.10.1.1** Expected credit losses are the weighted average of credit losses with the respective risks of default occurring as the weights. Credit loss is the difference between all contractual cash flows that are due to the Company in accordance with the contract and all the cash flows that the Company expects to receive (i.e. all cash shortfalls), discounted at the original effective interest rate (or credit-adjusted effective interest rate for purchased or originated credit-impaired financial assets). The Company estimates cash flows by considering all contractual terms of the financial instrument (for example, prepayment, extension, call and similar options) through the expected life of that financial instrument.
- **20.10.1.2** The Company measures the loss allowance for a financial instrument at an amount equal to the lifetime expected credit losses if the credit risk on that financial instrument has increased significantly since initial recognition. If the credit risk on a financial instrument has not increased significantly since initial recognition, the Company measures the loss allowance for that financial instrument at an amount equal to 12-month expected credit losses. 12-month expected credit losses are portion of the lifetime expected credit losses and represent the lifetime cash shortfalls that will result if default occurs within the 12 months after the reporting date and thus, are not cash shortfalls that are predicted over the next 12 months.

20.10.2 Impairment of non-financial assets:

As at the end of each accounting year, the Company reviews the carrying amounts of its PPE, investment property, intangible assets to determine whether there is any indication that those assets have suffered an impairment loss. If such indication exists, the said assets are tested for impairment so as to determine the impairment loss, if any.

Impairment loss is recognised when the carrying amount of an asset exceeds its recoverable amount. Recoverable amount is determined at the higher of the net selling price and the value in use.

Leases:

Assets taken on lease are accounted as right-of-use assets and the corresponding lease liability is recognised at the lease commencement date.

Initially the right-of-use asset is measured at cost which comprises the initial amount of the lease liability adjusted for any lease payments made at or before the commencement date, plus any initial direct costs incurred and an estimate of costs to dismantle and remove the underlying asset or to restore the underlying asset or the site on which it is located, as reduced by any lease incentives received.

The lease liability is initially measured at the present value of the lease payments, discounted using the Company's incremental borrowing rate. It is remeasured when there is a change in future lease payments arising from a change in an index or a rate, or a change in the estimate of the guaranteed residual value, or a change in the assessment of purchase, extension or termination option. When the lease liability is remeasured in this way, a corresponding adjustment is made to the carrying amount of the right-of-use asset or is recorded in profit or loss if the carrying amount of the right-of-use asset has been reduced to zero.

The right-of-use asset is measured by applying cost model i.e. right-of-use asset at cost less accumulated depreciation and cumulative impairment, if any. The right-of-use asset is depreciated using the straight-line method from the commencement date to the end of the lease term or useful life of the underlying asset whichever is earlier. Carrying amount of lease liability is increased by interest on lease liability and reduced by lease payments made.

20.11 Financial instruments

Financial assets and/or financial liabilities are recognised when the entity becomes party to a contract embodying the related financial instruments.

Financial assets and financial liabilities are initially measured at fair value. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities (other than financial assets and financial liabilities at fair value through profit or loss) are added to or deducted from the fair value of the assets or liabilities, on initial recognition. Transaction costs directly attributable to the acquisition of financial assets or financial liabilities at fair value through profit or loss.

The financial assets and financial liabilities are offset and presented on net basis in the balance sheet when there is a current legally enforceable right to set-off the recognised amounts and it is intended to either settle on net basis or to realise the asset and settle the liability simultaneously.

20.11.1 Financial assets:

20.11.1.1 Classification of financial assets

All recognised financial assets are subsequently measured in their entirety at either amortised cost or fair value, depending on the classification of the financial assets.

20.11.1.1.1 Financial assets at fair value through profit or loss (FVTPL):

20.11.1.1.1 Financial assets at FVTPL are measured at fair value at the end of each reporting period, with any gains or losses arising on remeasurement being recognised in profit or loss.

Financial assets are derecognized when:

- **20.11.1.1.1.1** the right to receive cash flows from the asset has expired, or
- **20.11.1.1.1.2** the Company has transferred its rights to receive cash flows from the asset or has assumed an obligation to pay the received cash flows in full without material delay to a third party under a pass-through arrangement; and
 - the Company has transferred substantially all the risks and rewards of the asset, or

• the Company has neither transferred nor retained substantially all the risks and rewards of the asset, but has transferred control of the asset.

On derecognition of a financial asset in its entirety, the difference between the carrying amount measured at the date of derecognition and the consideration received is recognised in profit or loss.

20.11.2 Financial liabilities

Financial liabilities, which are designated for measurement at FVTPL are subsequently measured at fair value. All other financial liabilities including loans and borrowings are measured at amortised cost.

A financial liability is derecognised when the related obligation expires or is discharged or cancelled. **20.12** Inventories

Inventories of stores, spares and consumables are valued, at the lower of weighted average cost or net realizable value.

20.13 Cash and bank balances

Cash and cash equivalents for the purpose of cash flow statement comprise cash in hand, cash at bank and demand deposits with banks.

20.14 Borrowing costs

Borrowing costs include interest expense calculated using the effective interest method.

20.15 Taxes on income

Tax on income for the current period is determined as per Tonnage Tax Scheme of Income –tax Act 1961 and based on the expected outcome of assessments / appeals.

20.16 Provisions, contingent liabilities and contingent assets

- **20.16.1** Provisions are recognised for liabilities that can be measured only by using a substantial degree of -estimation, if:
 - 20.16.1.1 the Company has a present obligation as a result of a past event,
 - **20.16.1.2** a probable outflow of resources is expected to settle the obligation and
 - **20.16.1.3** the amount of the obligation can be reliably estimated.

Reimbursement expected in respect of expenditure required to settle a provision is recognised only when it is virtually certain that the reimbursement will be received.

- **20.16.2** Contingent liability is disclosed in case of:
 - **20.16.2.1** a present obligation arising from past events, when it is not probable that an outflow of resources will be required to settle the obligation
 - 20.16.2.2 a present obligation arising from past events when no reliable estimate is possible;

20.16.3 Contingent assets are neither recognised nor disclosed.

Provisions, contingent liabilities and contingent assets are reviewed at each balance sheet date.

20.17 Cash flow statement

Cash flow statement is prepared segregating the cash flows from operating, investing and financing activities. Cash flow from operating activities is reported using indirect method, adjusting the net profits for the effects of:

- i. transactions of a non-cash nature;
- ii. any deferrals or accruals of past or future operating cash receipts or payments; and
- iii. items of income or expense associated with investing or financing cash flows

Cash and cash equivalents (including bank balances) shown in the statement of cash flows exclude items which are not available for general use as on the date of balance sheet.

20.18 Earnings per equity share

Basic earnings per equity share are computed by dividing the net profit attributable to the equity holders of the Company by the weighted average number of equity shares outstanding during the period.

20.19 Events after the reporting date

Where events occurring after the balance sheet date provide evidence of conditions that existed at the end of the reporting period, the impact of such events is adjusted within the financial statements. Otherwise, events after the balance sheet date only of material size or nature are disclosed.

(iii) Credit risk

Credit risk refers to the risk of default on its obligation by the counterparty resulting in a financial loss. However, Company has limited counter party risk as entire trade receivable is from joint venture partners and their group entities.

The Company has only two customers being joint venture partners and their group entities. Credit risk on cash and cash equivalents is limited as we generally invest in deposits with banks and financial institutions with high credit ratings assigned by international and domestic credit rating agencies.

(iv) Liquidity risk

Liquidity risk refers to the risk that the Company cannot meet its financial obligations. The objective of liquidity risk management is to maintain sufficient liquidity and ensure that funds are available for use as per requirements.
